Terms & Conditions

1. Gallery commission of 20% for members will apply to any works sold during the exhibition. Sold art works will be kept in the gallery until the end of the exhibition, unless determined otherwise by the Gallery Manager according to policy.
2. Entry is free.
3. Registrations are due by 26th January, 2025 and can be emailed to the BASI Installation Team at info@boonahartsociety.org or delivered directly to the Boonah Regional Art Gallery, High Street, Boonah.
4. Artworks to be delivered to the gallery from 1-2pm Sunday 9th February 2025.
5. The event will be open Tuesday 11th February – Sunday 13th April 2025. Dismantle and pick up from 1.00pm-2.30pm Sunday 13th April 2025.
6. **INSURANCE:** The Scenic Rim Regional Council in conjunction with the Boonah Arts Society Inc. will arrange insurance cover with the following understanding:

- 6(a) SRRC shall arrange Fine Art Insurance cover for all works during the display period. Cover will be based on the valuations provided by the Artist. Values must be based on current market value and be substantiated in event of a claim.
- 6(b) SRRC accepts no liability for loss or damage howsoever caused to any Artwork during installation or demount/removal of the artworks carried out by the Artist.
- 6(c) The Artist shall arrange and cover delivery/freighting and in transit insurance of all exhibition artworks to arrive on the delivery date. Return freighting and in transit insurance costs for unsold works shall be the responsibility of the Artist.
- 6(d) Due to limited storage capacity, SRRC and BRAG are unable to store works prior to the delivery date and unsold works after the exhibition period.
- 6(e) Please note that insurance value for artworks is the Sale price minus commission
7. Artwork must have a suitable hanging pockets with an appropriate length hanging rod with suitably sized (16mm) "D" hooks (not triangle hooks) at each end, and with no wires attached. For pieces on canvas and/or framed, your "D" hooks must be less than one third ($\frac{1}{3}$) from the top of the frame or in the case of a heavy frame or boxed frame 11cm from the top. All artworks must be clearly marked on the back bottom outside edge of the frame or canvas with artist name and title, or in the case of 3D art, on the bottom resting surface of the piece.
8. Money from sales will be paid, less the 20% commission, to the Artist/s at the end of the month after the close of the exhibition.
9. Artist/s provide photos of the exhibition pieces with the registration form to assist in installation planning. Photos must be clearly labelled with the artist name and title of work.
10. Artist/s agree that the artwork may be photographed or reproduced from their own photos for the following:
- 9(a) promotion of the exhibition, including social pages and print media
 - 9(b) to archive in order to provide a record for historical and insurance purposes.
11. Please ensure that as an Exhibiting artist/s you have not infringed and will not infringe the Intellectual Property Rights of any person with the production of your artwork. BASI and BRAG shall be indemnified and be kept indemnified by the artist against all liability, expense and costs whatsoever arising out of or in connection with any claim that their artwork infringes the Intellectual Property Rights of any person.
12. If necessary, the Exhibition Committee may withdraw any item/s from the exhibition because of insufficient spacing or unsuitable subject matter. The Artist/s will be notified if this step is taken and may appeal against the decision to the Management Committee of the Boonah Arts Society Inc.
13. Artist/s provide their art with the assurance that it has not been exhibited in Boonah Regional Art Gallery at any time previously.
